Confirmation of your registration, including an invoice, will be sent to you by email. Payments must be made within 14 working days from the date of confirmation. They can be made by bank transfer or secured online credit card payment and have to be in Euros (€). For on-site registration, only credit card payment is accepted, cheques and foreign currency are not accepted. An extra administrative charge of 50,00 € / Euro will be applied.

Cancellation and refund policy

- Written cancellations received up to and including 15 March 2009 will be fully refunded less an € / Euro 50 charge.
- Written cancellations received between 16 March and on 1 May 2009 will receive a 50% refund.
- Written cancellations received after 1 May 2009 will not be refunded.

Letter of invitation

Instructions for authors

1. All abstracts must be submitted online, using the appropriate form on the conference website (www.ou.nl/icde2009 > abstract submission).
2. Abstracts must be submitted by the presenting author.
3. Abstracts must be submitted in English.
4. Abstracts must not exceed 300 words (excluding abstract title, author names and affiliations).
5. Abstracts should be written in continuous text. Photographs, figures and other images and references should not be used.
6. Abstracts should be based on the above mentioned topics and indicate the referring items.
7. Abstracts should indicate the type of technical equipment needed for presentation.
8. Abstracts should contain a declaration that the proposed presentation is an original one which has not yet been given at or submitted to another event or publication and that all intellectual property rights and copyrights are with the author/s.

Evaluation and notification

Abstracts will be reviewed by the Programme Committee. The Programme Committee reserves the right to reject without further notice any abstract which does not apply to the principles of human rights and to the defined standards.

Notification of acceptance of abstract for parallel session or poster presentation or of non-acceptance will be sent via e-mail to the corresponding author by mid January, 2009.

If you have not received any notification on your submitted abstract by 1 February 2009, please contact the conference organisers at icde2009@ou.nl Notification on acceptance of abstract for presentation will include the invitation on preparing the full paper or poster for presentation according to defined guidelines.

Presentations

Abstracts will be considered for a presentation within the framework of the programme by the Programme Committee. Oral presenters should be prepared to speak for 20 minutes, after which 10 minutes of discussion are foreseen. All presentations must be given in English. No simultaneous translation will be provided. Further details will be announced accordingly.
